IMPORTANT NOTICE ALTERNATE SIDE PARKING BEGINS NOVEMBER 1.

Effective for 24 hours beginning at 5 PM. "PARK FOR TOMORROW"

Example: on December 1^{St,} on or after 5PM Park your vehicle on the Even Side of the Street.

ALL STREETS in the Village will have 24 hour alternate parking Except the following:

Miller St. (One Way) - Parking on S.West Side Only.

Note: No parking on Miller St. - Midnight to 7AM

No Parking allowed any time on these listed roads:

Church St.

Old State Road - Chenango to Rt.7.

Beacon St. - between Chenango and Kirkwood Ave.

If a vehicle is parked illegally & poses an immediate problem it will be towed at the owner's expense (plus storage costs) to expedite safe snow removal with reasonable consideration by the Police Department.

WINTER WEATHER REMINDERS:

SNOW & ICE LEFT ON SIDEWALKS: The

Village and or their contractors may clear such sidewalks of snow and ice if they are not cleared by the owner within twenty-four (24) hours after a **snowfall.** The cost of this removal will be assessed against the owner of the property. We will attempt to notify the owner and be reasonable with this enforcement as adverse weather conditions direct. Please be considerate and keep your sidewalks clear. Minimum charge is \$25 plus additional labor and melting materials costs.

DISCHARGING/SHOVELING SNOW INTO THE STREET IS ILLEGAL. This law will be enforced by the Police and Code Enforcement.

FIRE HYDRANTS: Please help yourself, neighbors and your Fire Department and help to keep our Hydrants clear of snow

EMERGENCY ALERTS: please be advised that **Broome County uses NY-ALERT as our All** Hazards Alerting Software. Register at www.nyalert.gov which is free. This enables you to receive emergency alerts for your area. For example these alerts would provide evacuation directions or flood related information.

POLICE DEPARMENT: wants to bring to your attention the following information and advice:

- UNLOCKED VEHICLES ARE BEING **ENTERED**. Remember to **LOCK YOUR VEHICLES** and your **HOME**.
- Close your garage doors when your no one is at home as you are only inviting problems
- Avoid leaving bicycles and other valuable items outside during the night.
- PLEASE Call the Police if you see or hear any Suspicious or Unusual Activity. No call is too minor.
- Door to door Solicitors are Police regulated. All solicitors must register prior at the Village Hall with proper ID. Registered solicitors are allowed from 9AM to sunset, not on Sundays or Holidays.

Evening, weekend & occasional day calls to the PD Police may be received by a Broome County Emergency Services Dispatcher. If at these times you have a problem (e.g. water or sewer) or desire to talk to an officer, just state your problem and request the dispatcher to have a Port Dickinson Police Officer visit you or phone you.

CODE ENFORCEMENT:

Storage of Containers:-"All garbage, recycling, debris containers shall be placed and stored behind the building out of view from the street or roadway. In no event may containers be stored in front of, in the front yard, or on the front porches of buildings. In the event any garbage can, recycling bin, or debris container or other related items cannot be stored out of view from the street or roadway, the property owner shall screen such areas of storage by opaque fencing and or plantings."

Garbage, Recycling and Lawn Debris Containersmay be placed to the curb after 2PM the day prior to the day of each pickup. Containers must be removed no later than 8PM the evening of that pickup.

VILLAGE NEWS & UPDATES: The Village Board is currently applying for grants to update and replace portions of our water system. Initially we are looking to replace the Water Mains on Chenango St. & Rochelle Rd.

A few homes in the Village have experienced dark water due to water main disturbances. Our supplier, the Town of Fenton has also had numerous complaints. We are working to alleviate the occurrences by flushing the system 2x a year, also target streets (eg. dead end streets) as needed. Please look for notices and signs at the Village entrances to be aware of the evening flushing's.

We have replaced the Water Pressure Reducing Valve in the new Metering Structure at the Village Border. This was done with Fenton as they built a new meter pit, saving the Village an extensive cost.

This is a safeguard against surges and high pressure.
