1. LOCAL LAW NO. 1 OF THE YEAR 2019: A LOCAL LAW AUTHORIZING A PROPERTY TAX LEVY IN EXCESS OF THE LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW §3-C

Mayor Burke explained that NYS is considering eliminating about \$23,000 of aid (income) to the Village as part of the NYS Budget. The Governor is proposing to tax internet sales, with a portion of that money coming back to the Village, to make up the difference. Mayor Burke explained that it is unknown how much the sales tax return would be and it is hoped that the Governor will change his proposal.
