Parks/Public Works:

A tree service will be coming in as soon as weather permits to cut & trim trees in the Park. Trustee Harding has met with contractors regarding bids for curbs and handicap ramps however no bids have been received.

Planning Board:

Next Comprehensive Plan meeting will be 5/21/19 at 5:00PM.

Public Safety:

The Port Dickinson Police Department responded to 97 calls for assistance, gave mutual aid 8 times. They wrote 34 Traffic Tickets and made two penal law arrests.

Water/Sewer :

- 1. <u>Hydrant Flushing</u>: Now underway in the Village. Expected to be completed by the end of Wednesday. So far, all hydrants are functioning as normal.
- 2. <u>Hot mix asphalt</u> has replaced the temporary fill at all street digs on water & sewer projects undertaken since the Fall closure of the hot asphalt plants. The exception is the dead end of Kirkwood Ave., which is expected to be paved curb-to-curb when DPW paves its other streets this year.
- 3. The Village paid its second installment of the 4 scheduled payments this year to the Binghamton-Johnson City Joint Sewage Board. The amount was \$62,802.

The Village supplies just over 1% of the total flow into the plant (1.1466% to be exact). Each of our 4 payments this year includes \$27,918 (44.45%) for Sewer Plant Debt Reduction. (about \$16/month per household).


- Mayor Burke reported that Engineer Lake attended the US Army Corp of Engineers meeting on flood plain risk.
