OLD BUSINESS:

• The \$100,000 NYS grant for Rochelle Rd water main replacement is supposed to be

received with the next couple of weeks.

- The Rochelle Rd project total was approximately \$543,000. There is \$155,774 in ARPA monies and the \$100,000 grant to apply to the cost. The remaining amount will be paid by a loan from the General Fund to the Water Fund. Attorney VanWhy will prepare the necessary forms.
- Attorney VanWhy has completed the letter to the Town of Fenton regarding overpayment of water fees to them and Clerk Fox will send on 6/11/25.
- Attorney VanWhy will prepare notice to the Town of Fenton regarding raising the sewer rate to \$1.57/100 cf. giving 120 day notice of the increase.
- Mayor Burke reported that Thoma Associates has indicated that CDBG funding is being held up at the Federal level. The Mayor will contact US Congressman and Senators for assistance.
