Spoke with owner of 688 and 711 Chenango St, some of the work was completed on 711 Chenango St and 688 will be started in spring


In court with 17 Bromley Ave and proof of engineers site visit was provided and will be awaiting the report so owner can apply for a building permit for the garage.
